

In exercise of the powers conferred by sub-section (2) of Section 4 of the Dadra and Nagar Haveli Value Added Tax Regulation, 2005 (No. 2 of 2005), (hereinafter referred to as the said Regulation), the Administrator, Daman & Diu and Dadra & Nagar Haveli hereby revises the rates of tax in respect of following items which were covered under Fourth Schedule, as follows:-

Sr. No.	Name of Item	Existing Tax	Revised rates of tax

1.	Diesel (High Speed Diesel, Super Light Diesel Oil, Light Diesel Oil)	20%	15%

The above items mentioned in column no. 2 shall be deleted from the Fourth Schedule to the said Regulation.
