**CIRCULAR**

At present Value Added Tax Department receives applications for VAT and CST Registration under Dadra and Nagar Haveli VAT Regulation 2005, online.

2. The registration certificate is required to be given within 30 days under Rule 12 of Dadra and Nagar Haveli Value Added Tax Rules, 2005. It has been desired under Ease of Doing Business to grant the registration certificate within one day in respect of non-sensitive goods atleast. Accordingly, all goods except Petroleum products, Chemicals, Acids etc. shall be categorized as non-sensitive goods. Registration certificate in respect of non-sensitive goods shall be granted in one day on completion of all formalities such as complete application including deposition of registration fees. Security etc. shall be obtained on registration.

3. The field inspection shall be carried out post-registration. All requisite documents relating to registration shall be obtained at the time inspection of the business-premises by VAT, Inspector within three weeks. The procedure for seeking registration for sensitive goods shall remain as prescribed in Dadra and Nagar Haveli Rules.

4. If any fact relating to registration is found incorrect the registration (TIN) so granted shall be cancelled forth with.
